NOW THIS ADDENDUM WITNESSETH AS FOLLOWS

21. In the event of any dispute or Claim between supplier and consumer in respect of or in any respect concerning or connected with the interpretation or implementation of this terms & conditions or arising out of this Agreements, either before or after this Agreement, such dispute or claim be referred to arbitration of a sole arbitrator to be appointed by CUGL and such arbitration shall be governed by the provisions of the Arbitration and Conciliation Act, 1996. The Fees, expenses, charges for the Arbitration shall be paid by the parties hereto in equal proportions. The decision of the arbitrator will be final and binding on both the parties. The venue of the arbitration shall be Kanpur.
